1. This agreement is made under the Israeli law Automotive and Professions (Licensing) Bill 5776-2016 (hereinafter "The Law") and Procedure No. 3/16 of Import Department Ministry of Transportation ISRAEL (hereinafter "The Procedure").
2. The Buyer wishes to obtain a license as Car Import Small Dealer from the Israeli Ministry of Transportation and this agreement is according to the law and the Procedure mentioned above.
3. The Buyer wishes to purchase from the Seller only cars which are under the directives and regulations of EC-European Union or the US Federal Motor Vehicle Safety Standards (FMVSS), and especially under the Emission standards.
4. The buyer wishes to purchase from the seller the following types of cars – Mercedes, Audi, Volkswagen, Land Rover, and any other type of car which the Israeli Ministry of Transport will allow him to import.
5. The seller is a car Dealer and has License and facilities to export cars from Germany.
6. The buyer wishes to buy only new cars as defined in section 1 of the law.
7. The seller undertakes that cars are not damage or involved with any accident and are **recall free**.
8. The seller undertakes **not** to send the vehicle to Israel before the buyer receives an import license.
